

Vogue Athletics – Chaperones

(for children aged under 18 years attending events without a parent/legal guardian)

Vogue Athletics recognises that it is not always possible for parents/legal guardians to attend cheerleading competitions/events with their child, although this is not our preference. In these circumstances, as part of our safeguarding procedures, we require that a chaperone be nominated to take full responsibility for the child for the duration of the event, including travel to/from the event and during any days/nights that the child is away from their parent/legal guardian in relation to the event.

Please be aware that as cheerleading events are unpaid, sporting activities, they are not under the jurisdiction of UK law regarding chaperones, therefore this chaperone agreement is an informal document for **Vogue Athletics** safeguarding purposes, it is not a legally binding contract. Children placed under the care of a chaperone for such an event is due to the legal requirements of parental responsibility, not a legal requirement of **Vogue Athletics**.

Vogue Athletics, including their directors, staff and volunteers (unless formally nominated as the chaperone) are NOT responsible for the whereabouts or the wellbeing of children outside of the specified days, times and locations in which we have requested them to be present for compulsory activities associated with the event.

Vogue Athletics strongly recommends that parents/legal guardians do adequate background checks, including requesting a valid DBS check, from any potential chaperone for their child.

Take full responsibility for the child during any optional activities associated	
with the event – I understand that during these activities, Vogue Athletics	
staff/volunteers are NOT responsible for the child.	
Be an example for the child, whilst they are under my care, by displaying positive	
conduct and behaviour.	
Ensure that the child is not exposed to or takes part in any activities that are	
either illegal, immoral or inappropriate for their age, for the duration of the time	
they are under my care.
